The Reporting Person disclaims beneficial ownership except to the extent of his and his spouse's pecuniary interest therein.
4. This transaction was executed in multiple trades at prices ranging from \$21.75 to \$21.79. The price reported above reflects the weighted average sale price. On previous Form 4 filings, the Reporting Person inadvertently reported incorrect numbers of securities beneficially owned in Column 5, which numbers were misreported due to an inadvertent administrative error that incorrectly calculated the actual amount of securities beneficially owned following the reported transactions. In fact, the amount of securities held by the Cheng Huang Family Trust immediately prior to the transactions reported in this Form 4 was 10,213,602 ordinary shares.
